# 2020 Fulton Ballot Saga

- Nov. 3 Fulton Co. **fails to count** Favorito vote for 3<sup>rd</sup> party presidential candidate
- Nov. 14 Senior poll managers find **counterfeit mail-in ballots** during hand count audit  
(No mail crease, toner copied, unusual paper stock, same votes down ballot)
- Dec. 3 Favorito files **ORR to view absentee ballot copies prior to certification**, sealing and delivery of ballots to clerk of court but gets no response
- Dec. 23 Favorito **Petitioners file** Equal Protection, Due Process case for vote dilution and court system assigns case to Judge Rachelle Carnesale



# 2021 Ballot Saga

- Jan. 4 
  - Chief Judge moves case out of district to Judge Brian Amero as election matter
  - Fulton Attorney Rosenberg finally replies **he did not receive the Dec. 3 ORR until Dec. 28** and ballots are now sealed pursuant to O.C.G.A. § 21-2-500
- Jan. 7 Judge Amero grants **temporary injunction to preserve all ballots**
- Apr. 20 Amero finds Rosenberg response untimely, deficient & in **violation of the ORA**

*We receive seven favorable rulings*



## 2021 Ballot Saga (SOS, AG)

- Apr. 2 SOS Raffensperger and AG Carr file amicus brief for Fulton attempting to prevent us from looking at ballots
- Apr. 19 We reply showing brief by Asst. AG McGowan had 5 major false statements
- May 21 **Judge Amero orders ballots to be unsealed**
- May 22 **Fulton hires criminal defense attorneys** just to prevent us from seeing ballots
- Jun 21 AJC falsely reports case was thrown out
- Sep. 20 Amero requests SOS to submit information about investigations and they say they looked at ballots and there no issues. **That is an admission of tampering.**



# 2022 Fulton Ballot Decisions

Oct. 13, 2021 Amero decides **petitioners have no standing** reversing himself after 10 months

Feb. 18 Petitioners file brief after our 11/10/21 appeal notice docketed

Jul. 1 Appeals Court upholds lower court ruling

Jul. 19 Petitioners file writ of cert to GA Supreme Court

Dec. 20 **Georgia Supreme Court confirms Fulton Petitioners have standing**  
unanimously without a hearing

The Honorable Supreme Court met pursuant to adjournment.

The following order was passed:

GARLAND FAVORITO et al. v. ALEX WAN et al.

The petition for certiorari is granted, the judgment is vacated, and the case is remanded to the Court of Appeals for reconsideration in light of *Sons of Confederate Veterans v. Henry County Board of Commissioners*, \_\_\_ Ga. \_\_\_ (Case Nos. S22G0039 & S22G0045; decided October 25, 2022). Petitioners' motion to expedite consideration of the petition for certiorari is dismissed as moot.

*All the Justices concur, except Pinson, J., disqualified.*

# 2023 Fulton Ballot Saga

- May 11
  - Appeals Court adopts Supreme Court ruling and **remands case to lower court**
  - Amero transfers case directly to McBurney ignoring standard procedure which should have returned case to Judge Carnesale
- May 16
  - Petitioners file **motion to recuse McBurney** in part due to due to extrajudicial **biased comments** made in Sen. David Perdue's similar ballot case
- Dec. 7
  - Judge Melynee Leftridge finds no conflict and **denies motion to recuse**



# 2024 - Fulton Claims Ballots Are Preserved



Jan-Apr Fulton attorney told Fulton criminal case judge in Harrison Floyd case

May 7 Fulton attorney told State Election Board

May 9 Fulton Elections Director told Fulton Election Board

July 24 Clerk attorney told Fulton civil judge in our ORR case

Nov 7 Fulton Elections Director told Fulton Election Board



# 2024 Fulton Ballot Saga

- June 24 Clerk requests permission from court to **destroy ballots** citing no storage room just weeks after Fulton leases new 600,000 sq ft. \$30 million warehouse
- July 1 Favorito submits ORR to Fulton BRE & Clerk for ballots
- July 10 The Fulton BRE replied: *“There are **no responsive documents** to your request”*
- July 11 Favorito submits ORR to the Clerk via the ORR falsely labelled as *‘Duplicate Request’*, **receives no reply and hand delivers ORR to clerk**
- Aug. 28 Favorito files a separate **ORR lawsuit, this one** against Clerk of Court and it is assigned to Judge Shakura Ingram





# 2025 Fulton Ballot Saga

- Jan. 1 New ballot ORR statute we requested takes effect O.C.G.A. 21-2-493 (j.2)(1)
- Jan 15 Clerk responds that statute **only applies to BRE, and no responsive documents**
- Feb. 19 **Favorito files ORR** to Fulton BRE for ballots and BRE responds:  
***“There are no responsive documents to your request.”***
- Oct. 22 Judge Ingram cancels ORR hearing on prior day transfers case to Judge McBurney
- Oct. 23 Favorito adds BRE as Defendant in ORR case
- Nov. 4 Judge McBurney grants motion to add BRE to clerk case

# 2024 Fulton Ballot Saga (SEB)

- May 7
  - SOS legal counsel tells SEB there were no significant Fulton 2020 violations
  - SEB finds 346 process violations and votes to monitor 2024 Fulton Co. elections (only county monitored)
- Nov. 5 **SEB issues subpoenas** for Fulton 2020 election records
- Nov. 15 BRE Chair Sheri Allen & Elect. Dir. Nadine Williams file **motion to quash subpoena without commission authority**



## 2025 Fulton Ballot Saga (SEB)

- Jul. 30 **SEB requests state & federal assistance** to obtain Fulton records
- Aug. 1 VoterGA provides **detail evidence supporting federal assistance request**
- Aug. 25 **DOJ criminal division requests ballots** from Judge McBurney
- Sep. 27 **SEB Votes to Subpoena Fulton 2020 election ballots**
- Oct. 30 DOJ civil issues **15-day demand letter** to Fulton for election records

# Gov. Kemp Report on Fulton 2020 Hand Count Audit

- July 13, 2021 VoterGA releases massive discrepancies from Fulton Nov. 2020 hand audit  
David Cross
- Aug- Oct Joe Rossi provides Gov. Kemp's office with evidence and explains it to them
- Nov. 15, 2021 Gov. Kemp report confirms discrepancies and concludes Fulton hand count audit did not match original results



# 2020 Hand Count Audit Discrepancies

- 60% of the tally sheets had incorrect totals that did not accurately represent the actual count of votes from the ballot images;
- Votes on over 4,000 ballots were double reported in the audit;
- Seven falsified tally sheets were created containing 800 votes for Joe Biden and none for Donald Trump and Libertarian Jo Jorgenson;
- Hundreds of double scanned, double counted ballots included in audit
- 6,000+ double votes counted with a net advantage for Biden 4,081

# Electronic Tampering

- Mar. 7, 2022 VoterGA study shows Fulton ballot images were altered before results certified  
[VoterGA.org/Studies](https://voterGA.org/Studies) tab
- July 8, 2022 Complaint alleges up to 58,924 certified Fulton votes have no source  
Joe Rossi, Kevin Moncla
- Apr. 30, 2023 SOS office finally initiates investigation after Gov. attorneys contact SEB chair  
SEB2023-025
- July 9, 2024 Three expert witnesses confirm allegations in SEB 2023-2025  
Clay Parikh, Ben Cotton, Garland Favorito





# SEB 2023-025 Findings

- 17,724 missing absentee ballot images for certified votes;  
128 more missing for scanned cast vote records that were never counted
- 20,713 in-person ballots with certified votes have no source tabulator tape;
- 3,930 double-scanned and double counted ballots;
- 17,234 unsourced ballots were batch uploaded and backfilled into election results by the CTCL\* funded Elections Group to reconcile inexplicable errors

# 1,003,763 Electronic Ballot Records Still Missing

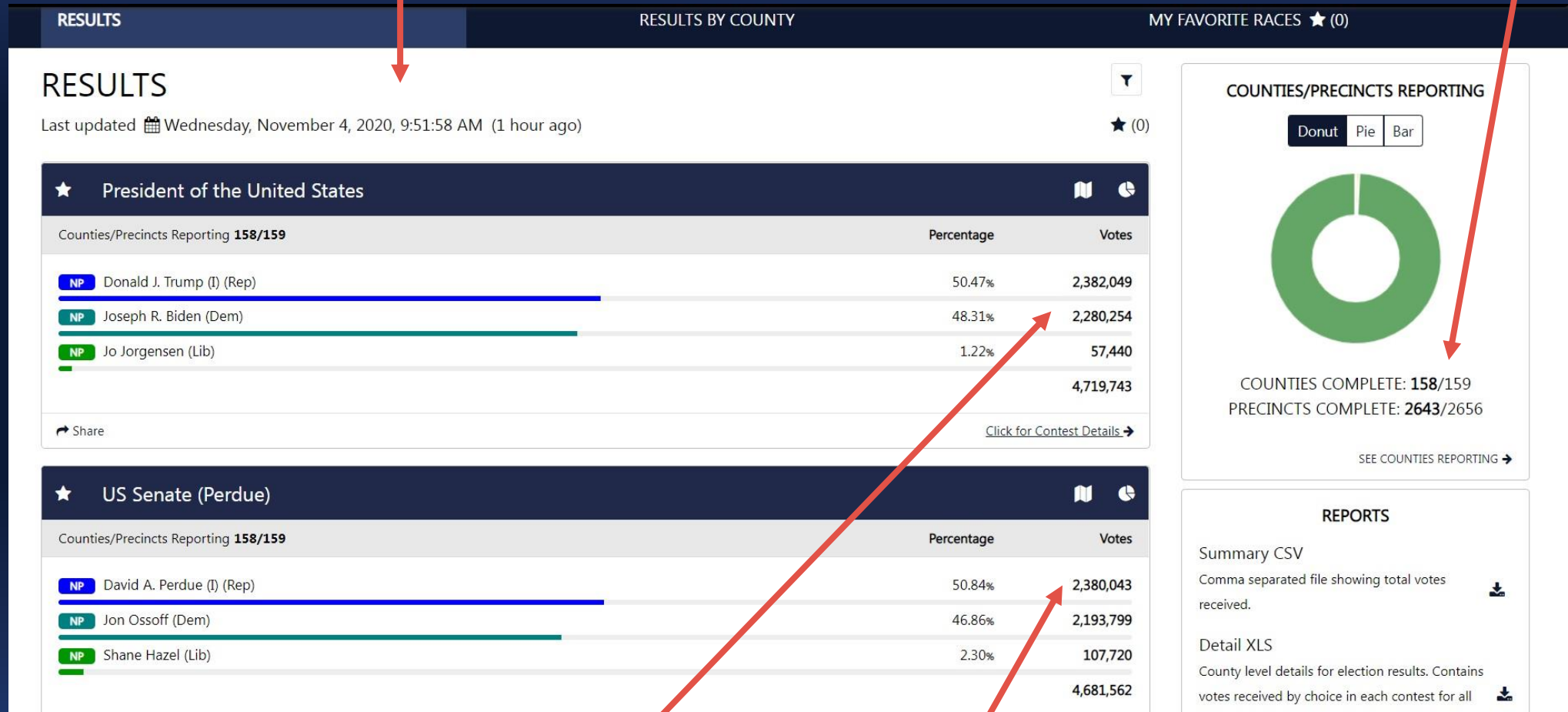
- 20,713 original AND recount ballots are missing tabulation records
- 17,852 missing recount ballot images
- 17,234 unsourced ballots batch uploaded to results to reconcile original count errors
- 17,852 missing recount Secure Hash Algorithm (SHA) authentication files
- 16,198 unsourced uploaded ballots added in results to reconcile recount errors
- 380,458 missing original in-person ballot images
- 512,743 more missing original SHA image authentication files

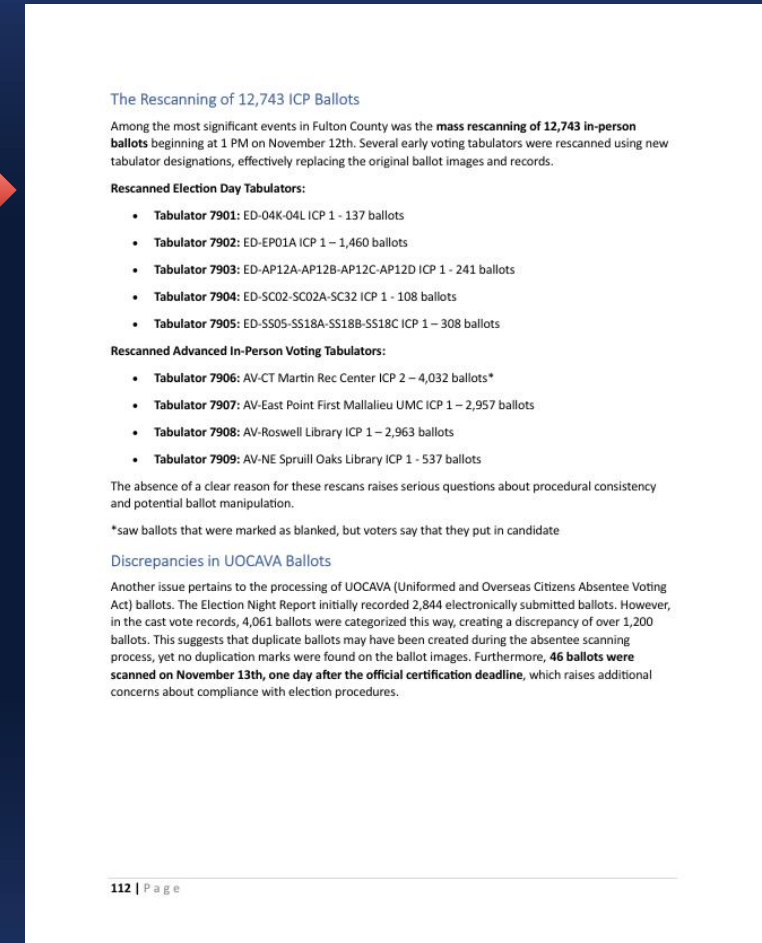
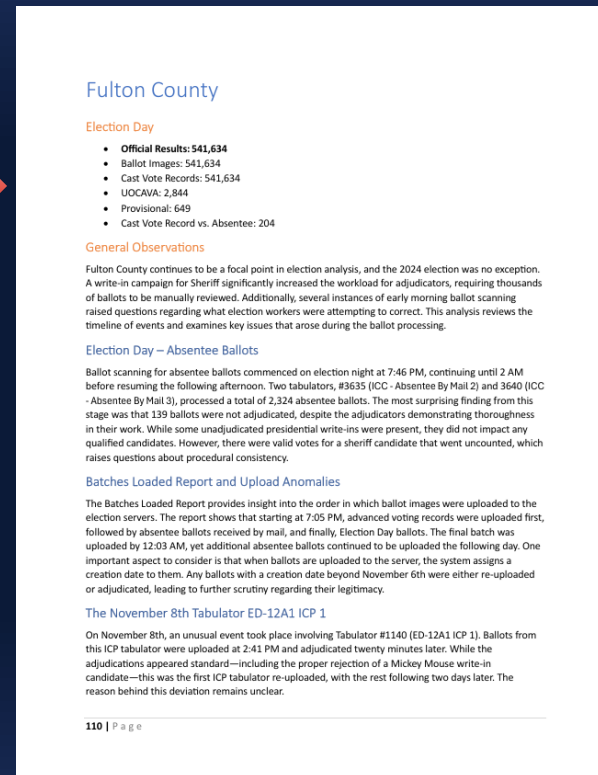
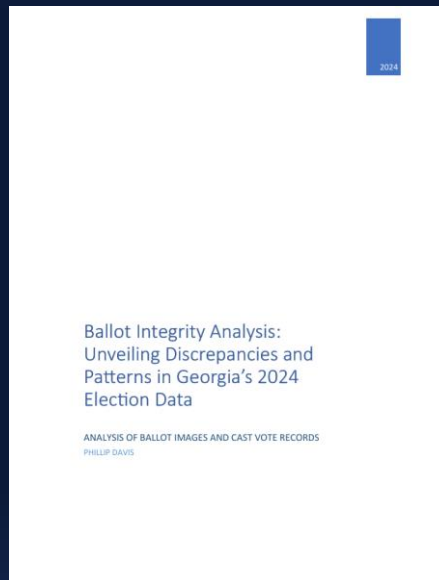

# Greatest Voting Rights Violation in GA History



Fulton Co. has blocked evidence of election crimes from being exposed for 5 years

Evidence clearly shows votes of Americans were diluted in the 2020 federal election

Voters are victims of a double standard of justice based on political agendas of judges

Some media outlets have been complicit in allowing the cover-up to continue
